#### About this form

The Application for Council Pensioner Rates Rebate form is produced by the NSW Division of Local Government-Department of Premier and Cabinet and this guide is intended to help the public correctly complete the application form at the time of submission.

#### Part 1: Rates Pensioner Rebate eligibility

To be eligible for a Rates Pensioner Rebate you must fulfil the following requirements:

- 1. The applicant/s on the forms must be the Owner/s (Ratepayer/s) for the property.
- 2. The applicant/s must hold a current Government issued Pensioner Concession Card and provide copies (front & back) of the card with their completed application form. NOTE: Senior's Cards and Health Care Cards are not accepted.
- 3. The property relating to the Application for Council Pensioner Rates Rebate must be the applicant's sole or principle place of residence.
- 4. Joint Owners - If joint owners are eligible for a pensioner concession, each eligible owner will need to provide their details and complete this form to receive the maximum rebate, otherwise only a partial rebate will be granted. If the property is owned by a couple and their spouse's name appears on the same Pensioner Concession Card, both owners should complete this form.

#### Change of eligibility status

Applicants who become or cease to be eligible pensioners during the financial year will receive a rebate proportionate to the number of full quarters in which they are an eligible pensioner.

#### **Company Title Owners**

All Company Title Owners must supply a copy of your Share Certificate in order to process your request.

#### Signatures on pages 4 and 5 of the Application form

The signature space on page 4 is the Applicant Declaration or prime signature for the form and the Customer Consent on page 5 is agreeing to allow the City of Sydney Council to obtain information from Services Australia with regard to Pensioner status and to advise of nominated bank account if a refund is to be credited. All signatures are needed in order for the City of Sydney Council to accept an application.

#### Proportion of concession to be received

The proportion of the pensioner concession received will be affected by:

- What proportion of the pension the property owner/s receive.
- What proportion of the property is owned by the applicant.

The final rebate amount will be calculated by Council Officers, who are regulated by NSW Department of Local Government Legislation.

#### ADDITIONAL INFORMATION

The City of Sydney will determine your eligibility to receive a rebate of up to \$250 on your rates account plus additional rebate amounts as resolved by the council each year. You may also be eligible to receive up to \$87.50 on your annual water charges and up to \$87.50 off your annual sewerage charges from your water/sewer service provider. Please contact your water/sewer service provider for more information.

#### **ELIGIBILITY**

- Holders of the PCC (Pensioner Concession Card)
- Holders of a gold card embossed with 'TPI' (Totally Permanently Incapacitated)
- Holders of a gold card embossed with 'EDA' (Extreme Disablement Adjustment)
- War widow or widower or wholly dependent partner entitled to the Pensioner Concession Card\*

Holders of cards other than those listed above are not eligible for the concession.
